Framework for the Nursing Curriculum

Person-Centered Nursing Framework:

The nursing curriculum is based on a person-centered nursing framework that centers on the following four foundational themes: Prerequisites; the Care Environment; Person-centered Process; and Outcomes. The overriding pillars for the UT Permian Basin nursing program are Caring; Scholarship; and Imagination.

It is believed by its authors (McCormack & McCane, 2006), that being person-centered requires the formation of a therapeutic relationship between professionals, patients, and significant others and that these relationships are built on mutual trust, understanding and sharing collective knowledge. The four major components of the model are:

- Prerequisites: Focus on the attributes of the nurse and include being professionally competent, having developed interpersonal skills, and being committed to the job, being able to demonstrate clarity of beliefs and values, and knowing self. Adjusted to these elements are the prerequisites academic courses that help nurses develop and discover knowledge of themselves and how that self-awareness impacts what they believe about the patient; provide skills for them to communicate and understand that the patient is central to all that takes place in the therapeutic relationship.
- Care Environment: Focuses on the context of where the care is provided; includes the culture of the environment, an appropriate mix of skills required by the patient and delivered by the nurse; systems that facilitate shared decision-making; sharing of power; creativity, innovation and imagination; and use of multiple sources of evidence to measure quality of care.
- Person-centered Processes: Focus on working with patient's beliefs and values; places value on what patients think about their lives and how they make sense of the world and what is happening to them during their illness or restoration to health. The nurse uses the prerequisite skills and courses in biology and social sciences to help keep patients safe and explain what patients seek to know about their condition.
- Outcomes: Focus on the expectations of the patient-centered relationship: satisfaction with care, involvement in care, feeling of well-being by the patient, and creating a therapeutic environment described as one in which decision-making is shared, collaborative staff relationships and innovative leadership and management of care. Adjusted to these qualities of the AACN Baccalaureate Essentials and the Board of Nursing Differentiated Competencies.

Admission Criteria

Your application to the UT Permian Basin School of Nursing consists of two application processes:

Please Read Carefully

First: Apply to the University of Texas Permian Basin

Prior to applying to UT Permian Basin School of Nursing, you must apply and be admitted to The University of Texas Permian Basin. Once admitted, you will receive your Student Identification Number that begins with 8000.

When applying to the University of Texas Permian Basin, please specify your major as "Pre-Nursing (General BSN) (NURSINT)". You must be a student of UTPB to apply for the BSN program.

Please note that acceptance into UTPB does not guarantee acceptance into the Nursing program.

Second: Apply to the UT Permian Basin School of Nursing

After acceptance to UT Permian Basin, you then complete a separate application to the UT Permian Basin School of Nursing to seek admission to the Nursing program.

The Nursing program is a highly competitive program. Not everyone who applies will be accepted into the BSN program.

The School of Nursing Admission Criteria is for students interested in applying for the BSN program.

Application Deadlines:

The application period for the Fall semester will open on the second Monday of January and close the last Wednesday of March. All general education courses must be completed by the end of May for the application to be considered as complete. Summer courses will not be considered for the Fall semester admittance.

The application period for the Spring semester will open on the second Monday in June and close the last Wednesday of August. All general education courses must be completed by the end of the current Fall semester for the application to be considered as complete. Mid-Winter courses will not be considered for the Spring semester admittance.

Applications Requirements:

Incomplete applications will not be reviewed. We encourage students to submit all required documents one week prior to the application deadline.

A minimum of 16 general education courses of the required 21 general education courses including the pre-nursing courses must be completed by the time the application is submitted. Students must provide enrollment verification for courses being taken during the application period to the School of Nursing at nursingadmissions@utpb.edu.

Applicants previously enrolled in any other nursing courses or nursing program must provide a Letter of Good Standing from the Dean or Director of the previous nursing program. Letter of Good Standing

must be sent to <u>nursingadmissions@utpb.edu</u> directly from the previous school. This letter will not be accepted directly from the applying student.

Required Courses and Grade Requirements:

- Overall cumulative college GPA of 3.0 or higher is required to apply to the School of Nursing.
- All science courses must be less than five years old at the time of application.
- Student must achieve a grade of B or higher in Biology I/Lab, Biology II/Lab, Anatomy/Lab, Physiology/Lab, and Microbiology/Lab courses.
- Only two attempts allowed to earn required Science grades.
- All prerequisites must be completed prior to admission to the nursing program (Junior Year, Semester 5).
- All remaining courses required to satisfy UTPB core curriculum and remaining School of Nursing prerequisites must be completed with a grade of C* or higher.
- PSYC 3301 Intro to Statistics and all NURS courses must be taken at UTPB.

*Please note – BIOL 3350/3151 Human Anatomy/Lab and BIOL 3352/3153 Human Physiology/Lab must be taken at the same University/College. (If a student takes Anatomy & Physiology (A&P) I or II at another institute, they must take the other Anatomy & Physiology (A&P) I or II course at the same college or another college that also offers Anatomy & Physiology (A&P) I or II.)

TEAS Test (Test of Essential Academic Skills, version 5 or higher) We encourage students to take their TEAS test as soon as possible, within the 2 year time frame of application.

- Student must achieve a 75% or higher on the Math and Reading sections of the TEAS. Science scores may be considered by the Admissions Committee. Scores must be less than two years old at the time of application.
- Test results must be sent to "U of TX Permian Basin BSN". TEAS test results must be received by the application deadline in order for the admission committee to consider the application complete.
- Only two attempts per application period are allowed to earn the required minimum scores in Reading and Math. Applicants must wait a minimum of 14 days between attempts. Scores from a TEAS test taken prior to the 14-day waiting period will not be considered. Scores from multiple attempts will not be pieced together, nor will single scores be evaluated.

Conditional Admission and Continued Progression:

Upon admission into the School of Nursing, the faculty is committed to the student's success in fulfilment of the Nursing Program. Students who are unsuccessful in their coursework (i.e. course failure), in both clinical and didactic courses, will require a determination by the Director of the Nursing Program to establish whether the student needs to: Repeat the course, Drop from the nursing major; and/or be disenrolled from the nursing courses (Students may repeat a nursing course one time and cannot fail more than two courses or two different courses from the time of admission). Students eligible to repeat a failed course will require a plan for success completed by the student and approved by the faculty. Subsequently, to progress in the Nursing Program, the student will complete, any incomplete courses, and satisfy all prior coursework. If a student is withdrawn from the Nursing Program, a degree plan for success will be determined by a nursing advisor and the Academic Advising Department. During this time, the student will meet with the recommended advisors to evaluate the best course to take in order to

complete the new degree plan. If the student is removed from the Nursing Program, yet wishes to pursue nursing, the student must wait one (1) year to re-apply and meet all admission criteria at the time of reapplication. Upon having met the requirements, the student may be eligible for re-admission.

Applicants who accept their position in the BSN program on two occasions and do not start the program will be ineligible for program consideration for two application periods (one year).

Rigorous study is required to succeed in the nursing program. Multiple hours are required beyond the classroom periods and clinical experiences. Students must be willing to accept this as a condition of succeeding in the program.

Selection Factors:

In addition to the minimum admission requirements, the following factors may also be considered:

- Extracurricular activities.
- Awards and honors for academic achievement, leadership, and community service.
- Communication skills, including bilingual ability.
- Awareness and direct knowledge of cultural elements as they may impact health care.
- Applicant's goals for the future.
- Academic histories and GPAs, with special consideration to the following: 12 or more credit hours in science courses with a B in each course completed at UT Permian Basin
 - the number of course hours successfully carried each semester,
 - the number of course failures and the dates of those failures,
 - the types of courses failed,
 - the number of times a course was repeated,
 - the number of withdrawals in comparison to hours enrolled, and
 - the number of withdrawal repetitions and the dates of those withdrawals.

The University may consider any or all of the following factors in making admissions and competitive scholarship decisions:

- socioeconomic background while in undergraduate school;
- an applicant's academic record as a high school student and undergraduate student;
- if an applicant would be the first of his/her family to graduate from a graduate or professional program.

Admission Status:

The Baccalaureate Admission Committee will begin review of each application as it is completed. Generally, students are notified of their admission status by the Nursing Program after all applications have been reviewed.

Criminal Background Check:

All nursing students are required to submit a criminal background check before enrolling in the School of Nursing. Information about the process is available at the Texas Board of Nursing website at http://www.bon.state.tx.us/. Because the process is fairly complex and must be finalized before starting the program, please be sure to start the process as soon as possible. For compliance purposes a copy of the response that you receive from the Texas Board of Nursing must be submitted with your Nursing Application.

Students who do not receive a clear background check from the BON must pursue the Declaratory Order process with the BON to confirm Eligibility for licensure.

Results of the Declaratory Order must be submitted to the School of Nursing. The Declaratory Order process permits the Board to make decisions regarding an applicant's eligibility for licensure prior to entering or completing a nursing program.

In addition, some clinical agencies require background checks to meet their corporate policies.

NOTE: Expunged and Sealed Offenses

While expunged or sealed offenses, arrests, tickets, or citations need not be disclosed, it is your responsibility to ensure the offense, arrest, ticket or citation has, in fact, been expunged or sealed. It is recommended that you submit a copy of the Court Order expunging or sealing the record in question to our office with your application. Failure to reveal an offense, arrest, ticket, or citation that is not in fact expunged or sealed, will at a minimum, subject your license to a disciplinary fine. Nondisclosure of relevant offenses raises questions related to truthfulness and character.

NOTE: Orders of Non-Disclosure

Pursuant to Tex. Gov't Code § 552.142(b), if you have criminal matters that are the subject of an order of non-disclosure you are not required to reveal those criminal matters on

this form. However, a criminal matter that is the subject of an order of non-disclosure may become a character and fitness issue. Pursuant to other sections of the Gov't Code chapter 411, the Texas Nursing Board is entitled to access criminal history record information that is the subject of an order of non-disclosure. If the Board discovers a criminal matter that is the subject of an order of non-disclosure, even if you properly did not reveal that matter, the Board may require you to provide information about any conduct that raises issues of character.

Required Immunization Status:

Students applying for admission to the UT Permian Basin School of Nursing must be immunized and provide information reflecting immunization against the following:

Bacterial Meningitis	If you are under the age of 30, are a new student, and/or you were not enrolled at UTPB prior to the effective date of January 01, 2012, you will be required to show evidence of bacterial meningitis vaccination
Hepatitis B	Documentation of 3 Hep B immunizations OR Surface Antibody titer (Anti-HBs, HBsAB) lab report showing immunity

Measles, Mumps, Rubella (MMR)	Documentation of 2 MMR immunizations, if born after January 1957. OR Quantitative titer lab report showing positive/immune result to each of the 3 diseases	
Varicella	Documentation of 2 Varicella immunizations OR Quantitative titer lab report showing positive/immune result	
Tetanus, Diphtheria, Acellular Pertussis (Tdap)	1 dose of Tdap within the past 10 years. Followed by a Td/Tdap booster every 10 years.	
Influenza (Flu) *	Annual flu vaccination provided in Fall/Winter each year (October 1st)	
Tuberculosis Testing *	Proof of annual PPD (within the past 90 days) OR Quantiferon or T-Spot blood test (within the past 90 days) IF Positive result, chest x-ray must be obtained, indicating a normal (negative) result. A yearly documented Tb assessment, and a normal (negative) chest x-ray every 2 years thereafter. IF Prior Hx of positive result, proof of positive result and proof of a chest x-ray (within the past 180 days), indicating a normal (negative) result is required. A yearly documented Tb assessment, and a normal (negative) chest x-ray every 2 years thereafter.

ACCEPTABLE DOCUMENTATION

Acceptable documentation of titers includes ONE of the following:

- A lab report including student name and date of test showing the disease tested for antibodies, the interpretation and the reference ranges.
- Hospital Employee Health record showing date and result of titer.

Acceptable documentation of immunizations includes ONE of the following:

- A completed immunization form that is signed by your health care provider.
- Documentation of vaccines administered that includes the signature or stamp of the physician or his/her designee, or public health personnel.
- An official immunization record generated from a state or local health authority, such as a county health department.

Acceptable documentation of exemptions/declination of immunizations includes the following:

- Documentation that includes the signature or stamp of the physician or his/her designee, or public health personnel indicating the reason for exemption/declination.
- Completion of forms required by UTPB SON and/or its' clinical affiliates.

Please Note:

- You must submit a copy of the laboratory report on all titers.
- We recommend that students keep a personal copy of their immunizations and titers for future needs.
- Healthcare Providers may not be aware of the requirements for student nurses. Approval can be secured by sending your documents for review to nursingadmissions@utpb.edu. In your email please include your student ID number and when you are planning to start the program.

^{**} Not required by UTPB but some clinical facilities may require the vaccine. Students may not attend clinicals if the clinical facility requirements are not met.

- Students working in healthcare should note that requirements for employees often differ from requirements for student nurses.
- Regarding the COVID-19 vaccine, the Centers for Disease Control and Prevention (CDC) recommends the following:
 - TB blood and skin tests should be delayed for four weeks after the second mRNA
 COVID-19 vaccine. However, these tests may be performed at any time before the first
 COVID-19 vaccine is administered.
 - No other vaccines should be administered for two weeks before or after either dose of the mRNA COVID-19 vaccine series.

All immunizations must be good for the entire semester.

This means that your TB and/or Tdap may not expire before May for a Spring semester, and December for a Fall semester.

Measles, Mumps and Rubella (MMR) Guidelines:

The Advisory Committee on Immunization Practices (ACIP) recommends routine MMR vaccination for the following groups of people:

- all children, beginning at age 12-15 months.
- adults born in 1957 or later without documentation of vaccination.
- healthcare workers, who lack evidence of immunity, regardless of age.
- non-pregnant women of childbearing age without evidence of immunity to Rubella
- ACIP recommends a second dose of MMR for any adult born during 1957 or later who:
- is a student in a post-secondary educational institution.
- is a healthcare worker.
- plans to travel internationally.
- Additional information on MMR Guidelines can be found on the <u>Immunization Action</u> Coalition website.

As mandated by Texas Administrative code, TITLE 25, PART 1, CHAPTER 97, SUBCHAPTER B, Rule § 97.64 Required Vaccinations for Students Enrolled in Health related and Veterinary Courses in Institutions of Higher Learning; students must have all required vaccinations in order to be enrolled and stay enrolled in a health-related course at institutions of higher education.

The School of Nursing follows policies set forth by hospital affiliates regarding immunizations, or test results and the ability of a student to attend class and/or clinical.

CPR

Students are required to be certified in Health Care Provider CPR from the American Heart Association. A copy of both sides of the card is required. The certification expires after 2 years. All students will be required to complete the CPR course either during student orientation or during the first clinical course (Fundamentals).

Letter of Good Standing

If previously enrolled in a nursing program, documentation of continued eligibility for that program must be provided. Admission of nursing students transferring from another nursing program will be determined on a case-by-case basis.

If a student leaves the School of Nursing to attend another school a Letter of Good Standing will only be given through the School of Nursing Administrative Offices. Student are not to ask faculty, instructors, staff or other university services for a Letter of Good Standing.

Blue Card

Students are required to have their Blue Card from the Texas Board of Nursing prior to orientation. If students do not have a blue card then admission will be deferred until the next semester, and the student must meet current admission requirements and re-apply. Admission will be contingent on space available and student's standing.

Nursing Insurance Requirements

Every nursing student is required by UT System to have health insurance.

UT Permian Basin nursing students completing hospital rounds and clinical visits during coursework are required to have a continuous medical insurance policy compliant with the federal Patient Protection and Affordable Care Act (PPACA).

The UT Student Health Insurance Plan (UT SHIP) meets the requirements. Enrollment in UT SHIP is automatic each semester and the insurance premium is automatically charged to your tuition and fee account when you register for classes. No action is required to be enrolled in UT SHIP except to ensure that your contact email and mailing address are always current in MyUTPB.

The UT System has established criteria by which a nursing student can request a waiver to the student health insurance plan by providing alternate health insurance coverage. To be approved for a waiver, your alternate health coverage must meet or exceed the requirements as set in the System regulation and be PPACA compliant. Please note that you must request a waiver each semester, regardless of showing proof of coverage for the full academic year.

An insurance letter detailing this information about UT SHIP requirements will be sent to your UTPB email each semester.

Please note that you must request a waiver EACH semester, regardless of showing proof of coverage for the full academic year.

In order to be approved for a waiver, your alternate health coverage must meet or exceed the requirements as set in the System regulation and be PPACA compliant. To verify that your insurance meets the requirements, you must submit your personal health insurance to show proof of adequate coverage. This is referred to as the "waiver process" because you are showing proof of insurance to "waive" purchasing the UT SHIP.

If you have your own insurance, you must complete the waiver process by showing proof of adequate coverage that covers you throughout the entire semester. You MUST complete your waiver on, or before, the deadline. The deadline will be included in the detailed insurance letter you will receive each semester. Failure to successfully complete the waiver process on or before the deadline, will result in your student account being charged for the UT SHIP which approximately costs \$1,300 a semester.

The mandatory coverage periods: August 15, 2024 to August 15, 2025.

The Waiver Process happens EACH semester a student is enrolled at UT Permian Basin School of Nursing. Therefore, if you have your own insurance, you must fill out the waiver EACH semester or you will be charged the nursing student insurance fee.

Urine Drug Screen

Healthcare providers, including nurses, are entrusted with the health, safety, and welfare of patients. We provide services that require quick and focused judgment and critical thinking, with clarity in thought. All clinical institutions must assure compliance with Joint Commission on Accreditation of Healthcare Organizations (JACHO) standard, including employees and students in the arena to be free from the influence of drugs. Further, responsibilities and standards in nursing practice are guided by the Texas Board of Nursing, national accreditation guidelines, and clinical agencies with whom the university holds contractual agreements. Nurses are held to a very high standard of care, integrity, and competency in order to provide responsible, safe care.

- All students conditionally accepted for admission/readmission into the BSN program will be required to undergo drug screening numerous times during their academic program of study. The screening will be done at the lab identified by the program and the cost will be paid by the student. The results will be submitted to the School of Nursing in a sealed envelope with a lab employee's signature on the seal. The student will hand deliver the envelope directly from the lab to the Clinical Coordinator at the School of Nursing.
- Failure to submit to drug testing will result in forfeiture of their admission into the program. Any conditionally admitted student whose drug screen is positive will forfeit their admission into the program. Positive results are kept confidential and will be shared with the program director or on site coordinator and Clinical Coordinator.
- Students in the program may be required to complete additional drug/alcohol screening required by the specific clinical agency, at the student's cost. Failure to comply with a clinical agency request for drug screening will result in dismissal from the site, and from course and program.
- Students taking prescription or over the counter medications are required to fill out a Student Medication List along with a faculty member and must have proof of prescription, and the list placed on file at the School of Nursing prior to drug screen initiation.
- If a student is arrested for any drug/alcohol offense while in the nursing program, they will be immediately withdrawn from the program and must go through the Declaratory Order process with the Texas Board of Nursing before the student can return to the program. Once the student is cleared by the Texas Board of Nursing, the student may request readmission to the program. The request for readmission will go before the Admissions/Academic Standards /Progression Committee for a final decision.
- All students enrolled in the program will be subject to random and for cause drug screening throughout their tenure in the program. Random dates throughout the student's time in the School of Nursing will be given to all students for drug screens. The random dates will be given to students via the Nursing email. If the student is unable to complete the drug screen in the 48 hours allotted time, it will be the students responsibility to contact the Chair of the program.
- Any time there is a complaint or report of a student suspected of being impaired, the student will be required to undergo drug testing. Should a student refuse to be tested or delay testing beyond the time frame requested by the School of Nursing this will be considered a positive screen and will result in immediate withdrawal from the nursing program. A drug screen which shows the presence of an adulterant will be considered a positive screen.
- Positive results on students admitted in the program require additional research that will be
 conducted by the School of Nursing and will require the donor (student) to be contacted to
 provide a prescription. Students must provide documentation within the time frame of 24 hours.
 Students with positive results that do not have a medically verifiable reason will be dismissed

from the program. If there is a medically verified reason for the positive result, the result will be changed to "negative."

• The cost for drug testing will be the responsibility of the student.

Drug Testing Procedure:

- **1.** All students will be required to complete a 12-panel drug screening. The 12-panel includes: [below is 12 plus alcohol]
 - Amphetamines
 - Barbiturates
 - Benzodiazepines
 - Cocaine
 - Methaqualone
 - Methadone
 - Methylenedioxymethamphetamine (Ecstasy)
 - Opiates (Codeine, Morphine, Heroin, etc.)
 - Oxycodone
 - Phencyclidine (PCP)
 - Propoxyphene (PPX)
 - Tetrahydrocannabinol (THC)
 - If a student is suspected of a positive alcohol (ETOH) level the student will be sent for testing at the student's expense.
- 2. The School of Nursing will provide an institutional sheet for completing the drug screen.
- 3. Students are responsible for the cost of the drug screen, paid to the laboratory. Collection of the specimen is done at the specific lab (Drug Screen Compliance). The lab is to provide results in a sealed envelope with a lab employee's signature on the seal, to the student and the student delivers the envelope to the Nursing Clinical Coordinator at the School of Nursing.

Drug Screen Results:

Laboratory results are evaluated by the Nursing Clinical Coordinator and the Director of the program in the School of Nursing. The following are the usual categories for results.

• Negative

Student has not been found with any level of drugs that will preclude them from continuing to the clinical observation, rotation, practicum, or placement. Students may proceed within their respective program courses.

• Negative or Positive Dilute: Inconclusive results

A urine specimen with creatinine and specific gravity values that are lower than expected for human urine: (DOT). The urine has more water or fluid than normal. The donor may have been well hydrated at the time of testing. A dilute positive or negative result is possible. If the sample was dilute to the point where the lab couldn't receive a result, then the test would be cancelled. The student must retest, and incur the cost of retesting, within 48 hours.

• Positive

Positive results on students admitted in the program may require additional research that will be conducted by the School of Nursing and will require the donor (student) to be contacted to provide a prescription. Students must provide documentation within the time frame of 24 hours. Students with positive results that do not have a medically verifiable reason will be dismissed

from the program. If there is a medically verified reason for the positive result, the result will be changed to "negative."

Next Steps:

Incoming and continuing students with

- Negative tests may proceed with program of study.
- Inconclusive test results, must retest, at student expense within 48 hours.
- Incoming student positive test results will result in removal from the program. Continuing students will be evaluated for consequences; if additional testing is required, it will be at student expense.

Consequences:

For positive tests on current clinical students, the policy recommended consequences will occur, including, but not be limited to the following:

- A. Allow student to retest.
- B. May be dismissed from courses, clinical rotations, and/or school for a period of time.
- C. Failure to complete a second drug test will be grounds to be permanently dismissed from the School of Nursing Programs.
- D. A second positive drug test will be grounds for permanent dismissal from the School of Nursing programs.
- E. Be dismissed from School of Nursing permanently.
- F. A referral for substance abuse counseling can be made but will have no impact on the decision to permanently remove the student from the School of Nursing.

Any student who has been out of the program for a semester or longer will be required to drug test prior to starting clinical.

Grounds for Disciplinary Action. (a) In this section, "intemperate use" includes practicing nursing or being on duty or on call while under the influence of alcohol or drugs.

Instructions will be given to students as to when Drug Screens will be completed.

Graduation Requirements

- To be eligible for graduation, a student must have attained a minimum 3.0 Cumulative Grade Point Average (CGPA) in the baccalaureate degree plan and a minimum Grade Point Average (GPA) of 2.5 in the Nursing Major.
- A candidate must successfully complete the prescribed curriculum and must meet all other requirements of the University and the College of Nursing.
- Eligible undergraduate degree candidates must submit a graduation application to the Office of Student Affairs.
- The Office of Student Affairs will review and forward all approved graduation applications to Registration & Records for processing.
- Registration & Records will post applicable charges to the students' accounts.

Orientation Attendance

Orientation attendance for student entering the BSN program is mandatory. Students will be informed of the dates for orientation in their acceptance letter. The student's acceptance offer will be rescinded if the students do not attend orientation in its entirety. The student may reapply for the next semester.

Academic Policies and Procedures:

Advising and Registration:

Advising is required before any student is permitted to register for courses. Nursing advising is conducted in the UT Permian Basin Academic Advising Center. It is the student's responsibility to take courses that are listed in the degree plan and the BSN Course Map must be followed as closely as possible the first four semesters and exactly as written semesters five (5) through eight (8). The student and their advisor are responsible for keeping the School of Nursing informed of any changes in course schedules. All courses must be completed to graduate from the University and take the NCLEX-RN Exam.

- A grade of C or better is required for each nursing course.
- In order to successfully complete each course, all assignments must be completed and turned in.
- Grades will not be rounded
- Extra credit or bonus points will not be awarded per the Texas Board of Nursing.

Scholarship Opportunities:

Nursing Students must submit their scholarship applications no later than the date set by the Scholarship Review Committee to have their application reviewed. Once the committee has reviewed the applications and presented recommendations to the Nursing Program Director the scholarship recipients will be notified by the School of Nursing Via email.

It is proper etiquette to send a "Thank you" letter to the scholarship donor within ten (10) business days from the day the email was sent. The student will be provided with an address of the donor by the School of Nursing. This letter should also be submitted to the Nursing Program within ten (10) days.

Student Employment:

The UTPB School of Nursing is a rigorous and time-consuming program. Students must carefully evaluate their personal and employment commitments to maximize their potential for success.

The School of Nursing assumes no responsibility for students employed in a healthcare agency. A student is personally responsible and liable for any activities conducted while employed. Supervision by a professional licensed nurse does not provide protection to the student or make the student's actions legal. Professional liability insurance purchased by a student is valid in the student role, but not in the employment role (check individual policies). An individual who practices nursing illegally may jeopardize his/her future as a licensed professional. A student employed with an agency has the

responsibility, personally and professionally, to engage in only those activities which fall within the job description for non-professional workers and has a responsibility to refuse to participate in activities which he or she has not been legally licensed to perform. Students working in the intern program are to be referenced and identified as "Unlicensed Assisted Personnel (UAP)" and uphold and work within the facility policies of a UAP.

Service Learning:

As a key component of the education process, the School of Nursing recognizes the need for students to participate in service learning. Service learning is attributed to experiential learning, community betterment and self-reflection. As a contribution to the University and the community, all students will be required to complete a minimum of four (4) hours of service learning each semester which will be counted as a grade. Any student not completing the Service Learning activity will fail the course under the policy "all assignments must be completed to pass the course". The service-learning opportunity must be approved by the course faculty. The service-learning opportunity may be separated into two separate experiences, but both should have a public focus, which can include a broad array of experiences.

The students will need to turn in their Service Learning Hours to the following course faculty:

- A. 1st semester NURS 3461 Foundations
- B. 2nd semester NURS 3370 Medical Surgical Nursing
- C. 3rd semester NURS 4280 Women's Health
- D. 4th semester NURS 4292 Advanced Medical Surgical Nursing

Emergency Contact Information:

Students will complete an emergency contact form to be kept in the students file incase an emergency situation arises. This form must be updated each semester.

Student Nursing Association:

All enrolled students are eligible for membership in the Nursing Student Organization, an affiliate of the Texas Nursing Students' Association and the National Student Nurses' Association, The UTPB Chapter's goals are consistent with those of the National Student Nurses' Association. Its purpose is to aid in the development of the individual student, the profession of Nursing, and the delivery of health care to all people.

Sigma Theta Tau:

The purposes of Sigma Theta Tau are to recognize the achievement of scholarship of superior quality, to recognize the development of leadership qualities, to foster high professional standards, to encourage creative work, and to strengthen commitment on the part of individuals to the ideas and purposes of the profession of nursing. Each year invitations to membership are extended to select students in either the undergraduate or graduate program who are within the upper one-third of their graduating class and who have a minimum 3.00 GPA.

Financial Aid:

The Office of Student Financial Aid assists qualified students in meeting the costs of college education. No person is excluded from participating based on race, color, national origin, sex, age, veteran status, disability, or sexual orientation.

Counseling and Psychological Services:

UTPB provides students, faculty, and staff a safe, vibrant, and healthy environment where wellness and well-being are supported and encouraged. Your health is your foundation and is critical to your success at

UTPB and your enjoyment of life in general. From basic healthcare to counseling and tobacco cessation, we are here to support your wellness journey. Health and Wellness link.

Undergraduate Catalog:

The <u>University Undergraduate Catalog</u> is available online. It contains helpful information, course descriptions, program information, admission requirements, etc.

Student Grievances/Appeal Procedures:

Students may file a grievance or appeal with the Dean of Student Services regarding grades, academic, or non-academic in nature. Instructions for the procedure may be found at Student Grievances.

University Guidelines

Regulations and procedures governing student life are outlined in the University Catalog. All students are responsible for knowledge of and compliance with these regulations.

At the time of registration and throughout enrollment in the School of Nursing, it is the student's responsibility to provide the School of Nursing with a current and correct (1) local address, and (2) telephone number. It is the student's responsibility to be informed of general and special notices including examination schedules and to make arrangements for the completion of all work including make-up examinations and requirements for removal of conditional and incomplete grades. Students are responsible for the University email issued on Canvas.

Nursing is a physically and mentally challenging profession. Nurses are required to think critically and quickly to respond to patient care needs. Nurses are also expected to be able to assist patients in transfer, ambulation and in activities of daily living. In order to do this, nurses must be able to lift, bend and be on their feet for extended periods of time (*Please see Technical Standards below and attached policy*). Students seeking application to the School of Nursing at The University of Texas Permian Basin, who may have limitations in any of the listed abilities, are advised to discuss these matters with the Office of Disabled Students to determine if "reasonable accommodations" could be provided. This must be done prior to choosing nursing as a major.

It is the responsibility of the student to inform the School of Nursing, Program Chair, and course and semester lead of any limitations they may have in completing course expectations. Written guidelines related to accommodations from the office of Disabled Students must be submitted to the School of Nursing, and course manager prior to the start of the course.

Accommodation for Students with Disabilities:

Students with Disabilities: The University of Texas Permian Basin in compliance with the Americans with Disabilities Act and Section 504 of the Rehabilitation Act provides "reasonable accommodations" to students with disabilities. Technical Standards:

The School of Nursing wishes to inform prospective students of the general nature of standard qualifications at or prior to admission into the nursing program. The following information is provided to enable applicants and accepted students to informally assess their own capabilities for nursing prior to entering the program.

These standards of performance are congruent with the Texas Board of Nursing expectations for a registered nurse. The use of trained agents is not permissible, due to the candidate's judgement would be facilitated by someone else's power of observation and reasoning, and the facilitator may infringe on the patient's HIPPA rights. Only applicants and students with disabilities covered by the ADA may be granted special accommodations in nursing classrooms, laboratory, and clinical settings. An individual must be able to independently, with or without reasonable accommodation, meet the following technical standards of general abilities and those specifically of (1) observation; (2) communication; (3) motor; (4) intellectual, conceptual, and quantitative abilities; (5) essential behavioral and social attributes; and (6) ability to manage stressful situations. Below list the technical standards for nursing students and nurses and a description and examples of each. Individuals unable to meet these technical standards, with or without reasonable accommodation, will not be able to complete the program and will be counseled to pursue alternate careers.

Tactile/Touch	Ability to perceive by feeling and touching	The ability to palpate and percuss functions of the physical examination, finger dexterity to perform skills such as insertion of a catheter, ability to perceive object size, shape, temperature, or texture. Ability to feel pain.

Communicate	Ability to communicate using written and verbal forms as well as understand others	The ability to write assessments and document plan of care as well as initiate verbal and written patient teaching, provide and receive an SBAR report, interpret nurses' notes, physician orders, and document nursing actions and the patient response. Interpersonal	Ability to conduct oneself in a professional manor	The ability to establish a proper nurse patient relationship and maintain professionalism with patients, families, students, faculty and colleagues.

The physical ability to lift and transfer 50 pounds and lift and carry objects up to 25 pounds. Able to bend or stoop 2 inches from the floor and able to reach overhead to retrieve or place items on shelves. Ability to use hands, wrist, and arms to physically apply 10 pounds of pressure while standing in the performance of procedures such as controlling bleeding or performing CPR, able to perform sustain repetitive movements such as full range of motion on patients, able to assist with mobility (ambulation of patients), position patients in bed, and move patients from a bed to a chair/wheelchair and return to bed.
Thinking Critically and Problem- solving	Ability to implement clinical judgement with critical thinking and problem-solving	Able to handle multiple task and problem solve simultaneously. Identify cause and effect relationships in clinical situations; utilize the nursing process in developing nursing care plans; and preforming accurate dosage calculations repeatedly and in a timely manner to deliver safe care.
Mobility	The physical ability to quickly move from place to place and maneuver in small spaces.	The ability to move around in patient rooms, confined spaces, workspaces, and treatment areas rapidly. Able to coordinate eyes and hands or fingers rapidly and accurately to complete precise movements when providing patient care.
Hearing	Adequate auditory ability to provide safe and effective patient care.	Able to hear with and without background noises, monitors, alarms, emergency signals, auscultation of sounds, and cries for help without the assistance of an interpreter potentially causing violations in HIPPA.
Smell	Ability to detect smells, including noxious odors.	The ability to detect and identify distinct body odors or body fluids. C-diff, alcohol breath, diabetes breath, or blood in stools. Detection of gases, and smoke.

Ethical Practice	Refer to the ANA Code of Ethics for Nurses Compliance with all HIPPA requirements regarding patient privacy.	Protect client privacy and comply with all legal requirements related to patient records. Avoid fabrication of reports or records of interactions with clients, social networking violations.
Professional Character	The ability to be truthful, caring, respectful and exhibit equality and fairness. Follow guidelines for professionalism and professional attire.	Accountable for behavior; self-disclose of errors. Show respect and compassion for all clients without regard to gender, age, race, ethnicity, sexual orientation, religious background, and social status. Adhere to dress code; Arriving on time to class and the clinical setting.

The School of Nursing is committed to ensuring that qualified students with disabilities are given equal access to its programs through "reasonable accommodations". The School of Nursing is not required to provide requested accommodations that would fundamentally alter the program, including patient and/or student safety in the clinical setting.

Prior to and upon BSN program acceptance, students must attest to their ability to meet these standards with or without an accommodation. If at that time a student requests an accommodation, the Office of

ADA for Students and the School of Nursing must determine if the accommodation is "reasonable" PRIOR to the student beginning BSN coursework.

General Communication:

Communication is expected to be professional in all encounters. Foul or abusive language in the classroom, clinical setting, or university will not be tolerated. Conflicts are to be resolved in a manner that respects the dignity of every person involved.

Email is an important communication tool used by the School of Nursing. Official communication must take place through the UT Permian Basin email system. The School of Nursing communicates with students using UT Permian Basin student email or messaging via Canvas Learning Management System. Faculty and staff members may not respond to emails from other servers such as Hotmail.com, gmail.com, yahoo.com, or other email servers.

Faculty in the School of Nursing will respond to emails within 24 hours on weekdays and 48 hours on weekends/holidays. Students should check UT Permian Basin email multiple times daily and respond to emails sent by faculty within 24 hours on weekdays, and 48 hours on weekends/holidays. Faculty members have office hours where they will be available for consultation. Days/times will be made available to you. Students are encouraged to contact their instructor if they wish to discuss their progress, a problem, or need assistance related to their role as a student.

Professional Behavior:

Professional behavior is an overriding value and requirement of the School of Nursing. Students are expected to always behave professionally with faculty, peers, preceptors, and clients and in any setting in which the student is a representative of UTPB. Furthermore, students' grades will be affected in either clinical or didactic courses for unprofessional behavior.

A student could be removed from the premises if the faculty or staff feel that their own or the other students' safety is at risk.

Bullying, verbal abuse, insubordination, or personal attacks will not be tolerated in any form. Any behavior deemed inappropriate by faculty, staff and/or preceptors will result in faculty conference(s), and completion of an "Unsafe/Unprofessional Behavior Report and Action Plan" that addresses the student's behavior and areas of needed improvement. Possible activities available to assist the student in attaining the improvement objectives include stress and/or anger management counseling sessions. Behaviors deemed inappropriate will result in removal from the clinical setting, Simulation Lab and/or classroom and will result in an administrative withdrawal from the course and/or dismissal from the program.

Attendance/Absences:

Attendance is mandatory for all courses. Students become more proficient in their learning when consistent active participation occurs. This participation means that the student is in attendance for the entire class.

When emergencies occur that prevent attendance it is the student's responsibility to inform the faculty. Notifying the faculty and appropriate clinical instructor of an anticipated absence is imperative. Notification of a clinical and/or classroom absence must be done by the student (according to the instructors preferred method; phone call, text, direct message, etc.) to the course faculty, clinical instructor (if clinical absence and contact information is provided), and clinical coordinator (if clinical absence) one (1) hour prior to the start of class or clinical.

There are no excused absences. Clinical absences will be reviewed for reasonable exemptions. Students can have no more than one (1) clinical absence a semester. The student will need to reschedule the clinical day and a student will receive a zero for the incomplete course work for that day. In the event a student misses more than one (1) day of clinical, including simulation lab hours, this will result in a meeting with course faculty and the Director of the School of Nursing course to determine course failure.

After the finalized schedule is in place then each student may exchange one (1) clinical day. This exchange may be arranged by contacting the course instructor and clinical coordinator.

Religious accommodations for class and clinical days may be arranged with the student's faculty member and the clinical coordinator. Students must schedule these days at the beginning of each semester.

If a student misses more than two consecutive class/clinical days due to illness the student must bring a note from a physician on office letterhead to return to class and clinical.

Students are expected to be in class ready to work prior to or at the precise meeting time and at the clinical site at the designated place and time to meet.

Once the class time has started the instructor will shut the classroom door and any student that is late cannot enter until a break is taken. If tardy back from break the student must wait outside the door until the next break.

- A. The absence/tardy counts are as follows:
 - 1. Three (3) tardies in a didactic course equals one (1) absence. If students are not in the classroom by the start time, they will be counted as tardy and cannot enter until the break.
 - 2. In a didactic course: on the third absences and a student is removed from the program.
 - 3. In a clinical course: the first absence will go to the Director for review, the second absence will result in removal from the program
- B. If a test is scheduled, students cannot enter the classroom tardy, they must wait outside the classroom until after the test is over and reschedule to take the exam with the instructor.

Any student in clinical not at the designated site and time will be sent home for an absence if a clinical class.

Extended Absence or Withdrawal due to Health Changes:

If a student misses four (4) weeks of class and/or clinical the student may drop the course if it is within the official drop dates set forth by the university, if the student does not drop within the drop date then they will receive a failure for the course. If the illness is identified outside of the drop date then the student will receive an incomplete, an action plan will be written listing a completion date, and an opportunity to complete the course will be given according to the action plan. If the student does not complete the course work by the date in the action plan the student will receive a failure (F) for the course. The student will be required to submit a doctor's note on letterhead clearing the student to return to courses without braces, splints, cast, crutches, slings, narcotics or muscle relaxers. If they are unable to perform the duties of the course, or they are given a doctor's release with stipulations (splint, cast, etc.) the student must drop the course prior to the drop date or receive a failure in the course.

Conditions that result in the inability to complete a clinical rotation include but are not limited to: acute illness, physical injury, mental health issues, pregnancy, or complications due to pregnancy, surgery, or chronic illness. Changes in a student's physical or mental condition that require activity limitations or the inability to participate in clinical or lab will require documentation from the student's healthcare provider. Documentation must be on facility letterhead and signed by the healthcare provider or designate.

Students must receive a full release with no limitations (e.g., splints, braces, cast, or certain medications, or other limitations that might interfere with safe patient care) to return to clinical. Limitations or restrictions may result in the need to withdraw from the clinical course.

Student Responsibilities:

It is the responsibility of the student:

- To become familiar with and comply with regulations of the University and School of Nursing;
- To keep the School of Nursing, Texas Board of Nursing, and Admissions Office informed of his/her current (1) local address, (2) telephone number, or where he or she may be reached, and (3) permanent address, phone number, and name changes;
- To notify the School of Nursing in writing within ten business days of a change of name and or address by submitting a legal document reflecting the change. Additionally, the student shall submit social security number and driver's license to the Program Director's office.
- To be informed of general and special notices including examination schedules received via email, posted on Canvas, and other official bulletin boards;
- To be flexible in personal scheduling to accommodate course didactic and clinical assignment changes from published days and times;
- To make arrangements for completion of all work and to meet the requirements for removal of incomplete grades;
- To assure that official communications, including request for release of information to other institutions be submitted in writing.
- Students are responsible for all content presented in lecture, lab and required readings whether in attendance or not. It is expected that students will utilize textbooks and other reference materials to fulfill course requirements.
- Taping is not allowed unless permission has been obtained from the instructor.
- Students who need taping as an accommodation for a disability must go through the UTPB Office of ADA for Students.
- Programmable devices (e.g., calculators and smart watches) are not allowed during testing, except when approved by the instructor.

Students and faculty in the School of Nursing have a responsibility for maintaining an appropriate learning environment. Faculty have the professional responsibility to treat students with understanding, dignity, and respect and to guide the teaching/learning process. Students are expected to refrain from inappropriate verbal and nonverbal behaviors in the classroom and clinical that may be distracting to others, such as, but not limited to: arriving late or leaving early, side conversations, text messaging, note passing, surfing the internet, checking Social Media, playing games or answering e-mail on laptops or smart phones, and answering cell phones. Students who persistently engage in behaviors that are disruptive to the teaching/learning process may be asked to leave or be removed from the area and the faculty and student must complete an "Unsafe/Unprofessional Behavior Report and Action Plan" that addresses the student's areas of needed improvement within 48 hours.

Three unprofessional behavior reports for insubordination, and/or non-compliance will result in removal from the program. Depending on the severity of the unprofessional behavior the student may be removed at any time prior to the third occurrence.

Preforming skills on a live patient prior to the student passing a competency or attending clinical unsupervised will constitute clinical failure and immediate dismissal from the School of Nursing. This includes any skills in the clinical setting which have not been demonstrated and graded in the Simulation Lab and performed in front of an instructor prior to performing on a live patient or preforming skills on a live patient without supervision at the clinical site.

If a student is found out to have performed a medical procedure during clinical or employment, the faculty aware of the situation will report the student to the Director of the School of Nursing and the Texas Board of Nursing. The Director of the School of Nursing will also contact the Chief Nursing Officer of the facility in which the student works to determine if the student is allowed to continue clinical in the facility.

Once the student is assigned to a nurse on their clinical floor if the charge nurse does not place their name on the assignment board next to the nurse they are following it will be the responsibility of the student nurse to do so.

All phones will be silenced and placed in purses or backpacks while in the classroom. If a student must receive a call, the student should notify the instructor prior to class starting and quietly leave the classroom to complete the call. All phones will be turned off and placed on a table at the front of the classroom during testing. There are no phones allowed in the clinical facility sites or simulation lab.

Student Conduct Policy

General Rules for Dress and Attire:

In order to assist the student in representing the University of Texas Permian Basin and the School of Nursing appropriately, the following dress code was established. These policies do not preempt additional requirements of the clinical agencies. Students **must adhere** to the dress code, regardless of setting, when wearing the UTPB School of Nursing uniform. Faculty reserve the right to counsel students observed violating policy.

Nursing Students will be held to a higher standard of conduct and dress attire than other students. Nursing students are expected to always maintain a professional image. Projecting a professional image is the responsibility of all students and faculty.

Students not complying with the dress code will not be allowed to participate in clinical. Any student unsure about dress code guidelines should contact their faculty. Failure to comply with the requirements below will result in the student being sent home, and an unexcused clinical absence will be the outcome, which may result in clinical failure if it is the student's second absence.

The approved School of Nursing uniform must be worn in the nursing classroom, study hall, nursing simulation lab, the hospital clinical setting, when meeting with instructors, and possibly for formal ceremonies unless otherwise directed by faculty.

School of Nursing Uniform:

Uniform: Uniforms must be clean, wrinkle free and neat at the beginning of each clinical day and no individual pieces of the uniform are to be worn alone. Black or gray t-shirts or turtlenecks without writing or symbols are acceptable under the uniform top.

Name Badge: The official UTPB School of Nursing picture ID will be clearly visible and worn at all times above the waist on the scrub top. When at the facility clinical sites the student will also wear only the badge for that hospital site. All hospital badges and badge buddies will be returned at the end of each semester to the clinical coordinator.

Lab Coat: Plain white mid-thigh laboratory coats are required when students enter community agencies for certain clinical assignments, or for purposes other than providing direct patient/client care. The official nametag must be on the left side of the lab coat above the pocket.

Shoulder Patch: The official UTPB School of Nursing patch must be on the left shoulder of the scrub top. Patches are available from the UTPB SON administrative assistants.

Professional attire: Professional attire **excludes** denim, shorts, T-shirts, sweatshirts, shirts of undergarment type, see-through clothing, leggings and any clothing that exposes a bare midriff, back, chest, Spaghetti strap, strapless, or one shoulder shirts or dresses, skirts or dresses more than 2 inches above the knee, or exposed undergarments. A gray polo with the UTPB patch on the front upper left of the shirt and tan or black pants/slacks are considered professional.

Professional Appearance and Demeanor demands a daily personal hygiene routine (bathing, deodorant, hair care) and excludes perfume, cologne, lotion/make-up with glitter, gum chewing and excessive make-up.

Students are to refrain from public places, such as grocery stores, restaurants, bars, etc., while wearing the uniform with its identifying patch and nametag.

Eyelashes: False eyelashes will not to be permitted at any time.

Shoes: Black close-toed/heeled shoes with matching shoelaces are worn with the uniform and should be well fitted, comfortable and free of decoration. They must be clean at the beginning of each clinical day. Canvas shoes, flip-flops, or non-enclosed shoes are unacceptable.

Tops: Approved grey scrub top (available for purchase at Scrubs and Duds or on-line, or any general merchandise store as long as the grey color is correct) with logo patch sewn on the left sleeve. No flair or decorative trim allowed.

Pants/Skirts: Scrub pants must be black in color. Scrub pants may not drag on the floor, be low-rise, or jogger style. A black scrub skirt (must touch top of kneecap), may be worn. The pant/skirt must be correctly fitted.

Socks: Support stockings, or ankle socks are required as part of the uniform.

Jewelry: One **small** stud earring per earlobe is acceptable. One **small** nose stud may be worn. No rings or multiple nose piercings. No dangling earrings, piercings in or around the mouth, eyebrow piercings or visible retainers used to keep piercings open.

Tattoos: Must be covered by sleeves. Neck and facial tattoos must be covered with make-up or Band-Aids.

Fingernails: Fingernails will be clean and evenly trimmed to the tip of the finger. No artificial fingernails, fingernail adornment, jewelry, or polish is permissible.

Hair: Hair must be clean and neat. The hairstyle must be neatly arranged off the face and the uniform collar (ponytails, with hair exceeding the collar are not allowed, all hair must be off the face including bangs). Hair must be of a natural color, i.e., no green, un-natural red, orange, purple, blue etc. colors are permissible. Decorative hair ornaments are not permissible: (ribbons, bows, glitter, hats, etc.)

Facial hair: Beards and moustaches will not to be permitted at any time.

Smoking: Students will refrain from smoking in clinical attire since smoke clings to fabric and may be irritating to patients and family members.

Jackets: Outer garments worn with the School of Nursing uniform must have the UTPB patch and be in a matching color to the uniform. Outer garments are not permissible in the clinical agency unless special permission is obtained from that agency. No hoodies.

Alternate clinical settings: In clinical settings where the uniform is not required, a gray polo with the UTPB patch and tan or black pants/slacks are required along with official UTPB picture ID badge.

Uniforms Accessories such as lab coats and shoes may be purchased at any uniform shop.

Mobile Phones: It is the decision of the faculty for the clinical course if cell phones will be allowed in the clinical area. The phones must be turned off in the clinical setting, placed in backpacks and may only be used during breaks away from the patient care setting (patient floors). Phones with cameras are never allowed in patient areas and the use of mobile phones for talking or texting is also prohibited in patient care settings.

Mobile phones are only permitted in the clinical setting as a PDA to look up information or to contact the clinical instructor.

Students who fail to follow the dress code will be asked to leave the clinical setting and they will be required to complete an action plan for improvement per the clinical instructor and/or course faculty.

Any student whose personal appearance or hygiene creates anxiety, concern, distress, or fear will be immediately removed from the clinical site and addressed, regardless of whether the appearance falls within this policy (example: hair color, tattoos, makeup, etc.).

Students will be dismissed from class or clinical for inappropriate attire. Any instructor may dismiss a student from any class for not following rules and/or dress code.

As a professional courtesy, please honor our University by not wearing other schools emblems, shirts, jackets, scrubs, etc.

Violations of class, clinical, or lab dress requirements will result in the following consequences:

Students deemed inappropriately attired by any clinical/laboratory or didactic faculty will be counseled, asked to leave the class or clinical site, and complete an action plan for improvement. The time missed will be counted as an absence, considered unexcused, will not be rescheduled, and will contribute to clinical failure if it is the second absence.

Safe Practice:

All nursing students must perform within the limits of safe practice. A faculty member or clinical instructor will recommend the student be dropped from a course with a course grade of an "F" if the student is deemed unsafe.

Students who are unable to pass a clinical skill check-off in three (3) attempts will receive a failing grade "U" in the clinical course causing an "F" to also be assigned to the didactic course. Between each attempt, the student must remediate with a CTS or the course instructor for at least one (1) hour prior to the next check-off. If a student progresses to the third attempt and prior attempts were not complete with an in person instructor, the third check-off must be completed with an instructor present as well as being recorded. If the student has no other NURS course failures the student may repeat the courses in the following semester, and may not continue with courses in the next semester until the failed course is completed. If the student has received a previous course failure the student will be removed from the nursing program and if meeting all admission criteria at the time of application may apply in one (1) year for consideration of acceptance.

Students must meet all clinical requirements to participate in clinical. Failure to meet all clinical requirements will result in course failure and/or removal from program.

Medication Administration:

Students may not give medications until they have been checked off by faculty in the simulation area and have achieved the minimum score requirements on the Dosage and Calculations Exam. After simulation check-offs are passed, students may only give medications if supervised by their clinical instructor the first time they are giving medications to a live patient in the facility. Once the instructor has witnessed the successful medication administration the student may at that time give medications supervised by a nurse they are following on the floor. *Failure to adhere to this policy will result in clinical failure*.

Students must take a 25 question dosage and calculations exam each semester. Students must pass the exam within two (2) attempts in order to progress to the next semester. If a student fails the first attempt they will be required to remediate and attend study hall until the next test is taken. If, after the second attempt, the student does not make the required grade the student will fail both didactic and clinical courses and will have to retake the courses the next semester and pass both before they are allowed to progress. This will count as one failure towards the two allowed failures. The student may continue and complete all other courses in that semester

The exam will be given in the following courses with the mandatory grade for each semester as follows:

Clinical Failure:

Demonstrating any unsafe clinical practice that places the patient, client, family, staff, faculty, or other student in physical or emotional jeopardy which would include neglect, abuse or purposely injuring others will not only require immediate removal from the facility by faculty, it will constitute Clinical Failure and result in immediate removal from the student's remaining clinical until the incident has been reviewed and a decision is made by the director of the program to dismiss the student from the School of Nursing.

Physical jeopardy is the risk of causing physical harm.

Emotional jeopardy means that the student has created an environment of anxiety or distress which puts the patient/client/family/staff/faculty/other student at risk for emotional or psychological harm.

Students, who earn any unsatisfactory (U) on their final course evaluation, have not met the course objectives and have failed the course. Nursing is a practice profession in which patient and family safety must be protected (Texas Board of Nursing). <u>If clinical performance (including failure of the dosage calculations exam) has been deemed unsafe, students may not drop or withdraw from any clinical course. They will be immediately removed from the clinical setting, forfeit further clinical experiences, and receive a grade of "F".</u>

The following Clinical Failing Behaviors will result in a clinical failure regardless of the drop or withdrawal date and are based on professional nursing standards set forth by the Nurse Practice Act, the Texas Board of Nurse Examiners, and program policy related to patient safety in the clinical setting:

- 5. Accepts assignments commensurate with educational level, preparation, experience and knowledge 217.11.
- 6. Obtains instruction and supervision as necessary when implementing nursing procedures or practices 217.11
- 7. Notifies the appropriate supervisor when leaving an assignment 217.11.
- 8. Recognizes and maintains professional boundaries of the nurse/patient relationship 217.11.
- 9. Clarifies orders, treatments, that nurse has reason to believe are inaccurate, non- effective or contraindicated 217.11.

- 10. Able to distinguish right from wrong 213.27.
- 11. Able to think and act rationally 213.27.
- 12. Able to keep promises and honor obligations 213.27.
- 13. Accountable for own behavior 213.27.
- 14. Able to promptly and fully self-disclose facts, circumstances, events, errors and omissions when these disclosures will enhance health status of patients or protect patients from unnecessary risk or harm 213.27.

Refer to the Board of Nursing at www.BON.state.tx.us for any additional information regarding the Texas Nursing Practice Act.

Removal from Clinical Site:

A student may be removed from the simulation lab or facility clinical site by the clinical adjunct, faculty, clinical teaching specialist, clinical coordinator, or director for any of these behaviors:

- Failure to come to clinical prepared including dress, supplies, and/or assignments.
- Arriving at clinical site but not reporting to floor in time to get report (e.g. going to cafeteria and eating breakfast prior to start of scheduled shift).
- Absence from floor for more than 30 minutes for lunch.
- Not reporting to clinical nurse or charge nurse prior to leaving the floor for any reason.
- Tardiness: Students are required to be at clinical by the specified time no arriving late.
- Unprofessional communication behaviors: profane language or incivility with patients, visitors, staff, faculty, or other students.
- Inappropriate use of personal communication devices in the clinical setting (cell phones, tablets, iPads, or personal computers).
- Failure to treat others with respect, honesty, and dignity.
- Inability to implement empathetic care.
- Inattentiveness to clinical work as exhibited by being unavailable for patient/client care, engaging in personal discussions, etc.
- Sleeping
- Failure to implement appropriate action to ensure safety of patients/clients.
- Additional behavior(s) which the faculty deems unprofessional including being disruptive during clinical time, insubordinate, or non-compliant, with faculty instruction or facility policy.
- Arriving at clinical setting under the influence of alcohol or other substances that can impair judgment.
- HIPAA violation or any breach in patient confidentiality.
- Misuse or unauthorized use of computer resources or information.
- Badging another student into the computer system, asking another student to badge you into the computer system, or badging another student through locked doors in which they do not have access. Sharing of passwords to the computer system or any other password protected devices.
- Purposeful destruction of property in the simulation lab, or at the clinical site.
- Stealing of supplies, medications or anything that belongs to the clinical setting (e.g., Simulation lab or clinical facility).
- Failure to comply with course or clinical site policies and protocols.

Any one of these violations may constitute failure of the course and/or dismissal from the School of Nursing.

Removal from Class:

A student may be asked by any member of the faculty to leave class for any of these behaviors:

- Excessive tardiness to class or upon returning from breaks. If a student is tardy to class (either at the start or coming back from break) the student must remain outside the classroom until the class has a break to enter. If the student is late to a test they must wait outside until testing is complete and then meet with the instructor after class to schedule a makeup for the test.
- Disruptive or disrespectful behavior toward faculty and/or other students.
- Inattentiveness to classroom work.
- Sleeping
- Talking or texting on personal communication device/phone.
- Or any other behavior deemed disruptive.

Consequences of Unprofessional Behavior:

When problem behaviors are identified, the involved faculty member will:

- 1. Complete an "Unsafe/Unprofessional Behavior Report and Action Plan" within 24 hours.
- 2. Counsel the student on unacceptable behavior indicating the type of behavioral change that is expected and within what time frame.
- 3. A learning prescription may be written which will document the behavior, expected response and the period for remediation/improvement.
- 4. Document the need for an Unsafe/Unprofessional Action Plan in EAB.
- 5. If the behavior is a major infraction or no improvement is seen within the time frame documented, the student will be counseled by faculty and will be referred to the Progressions Committee, and forwarded to the School of Nursing director. Sanctions will be taken, which could include any of the following:
 - grade reduction,
 - course failure,
 - suspension,
 - dismissal from the class, or
 - dismissal from the School of Nursing
 - dismissal from the university.

A student could be removed from the premises if the faculty or staff feel that their own or the other students' safety is at risk.

Progression Committee:

The Progression Committee will meet regarding acts of unsafe and unprofessional behavior. Any student exhibiting unsafe and unprofessional behavior will have a written Unsafe/Unprofessional Behavior Report completed by the instructor and sent to the Progression Committee. The student will be allowed to submit their response to the written report and the committee will meet to discuss the report, the response, the outcome, and consequences of the behavior.

Depending on infraction, consequences may consist of:

- verbal warning with a written account of the verbal warning,
- formal written statement that may go against student's completion of the program
- removal and failure of the course
- removal from the school of nursing program, with reapplication in one (1) year for readmission consideration.

Confidential and Sensitive Information:

Students will have access to confidential medical records and sensitive information regarding the patients, families, and community agencies while providing nursing care as a student. Students must agree to maintain the highest standards of professional integrity regarding this information and comply with all legal requirements regarding the privacy of patient records. This includes but is not limited to written, verbal, and electronic social---networking transmission of information. Consequences: The consequences of any breech in maintaining confidential and sensitive information will result in disciplinary action up to and including expulsion from the nursing program.

Professional Writing/APA:

The newest edition of the APA style manual will be used by the UTPB Department of Undergraduate Nursing with some specific requirements for the undergraduate courses.

Use of Social Media by Students:

To ensure the confidentiality and privacy of patients through social media, the School of Nursing and students will abide by the guidelines of The Texas Board of Nursing Position Statement on Social Media.

Use of Social Media by Nurses:

With the rapidly growing use of social media sites and applications such as Facebook, X, TikTok, Snapchat, LinkedIn, YouTube, Pod Cast, and blogs, professional obligations to patients, peers, and employers may be unclear. While the Board recognizes that the use of social media can be a valuable tool in healthcare, there are potential serious consequences if used inappropriately. Online postings may harm patients if protected health information is

disclosed. These types of postings may reflect negatively on individual nurses, the nursing profession, the public's trust of our profession, as well as jeopardize careers.

Both the National Council of State Boards of Nursing (NCSBN) and the American Nurses Association (ANA) endorse each other's guidelines and principles on the use of social media for it to be used appropriately and without harm to patients.

Students may not post any disparaging comments about clinical, classroom, or about faculty, staff or other students. This is strictly prohibited by the UT Permian Basin School of Nursing.

The benefits of social media are many, and include:

"Networking and nurturing relationships, exchange of knowledge and forum for collegial interchange, dissemination and discussion of nursing and health related education, research, best practices, educating the public on nursing and health related matters" (ANA, 2012, para. 4).

However, if used indiscriminately, the risks are great, and include:

- "Information taking on a life of its own where inaccuracies become fact.
- Patient privacy being breached.
- The public's trust of nurses being compromised.
- Individual nursing careers being undermined" (ANA, 2012, para. 5). In a recent survey by the NCSBN, many of the responding boards reported that they had received complaints about nurses inappropriately using social media sites. Nurses have been disciplined by boards, fired by employers, and criminally charged for the inappropriate or unprofessional use of social media (NCSBN, 2012).
- To ensure the mission to protect and promote the welfare of the people of Texas, the Texas Board of Nursing supports both the guidelines and principles of social media use by the NCSBN and ANA.

In keeping with the NCSBN guidelines, it is the Board's position that:

- Nurses must recognize that they have an ethical & legal obligation to maintain patient privacy and confidentiality at all times.
- Nurses are strictly prohibited from transmitting by way of any electronic media any patient-related image. In addition, nurses are restricted from transmitting any information that may be reasonably anticipated to violate patient rights to confidentiality or privacy, or otherwise degrade or embarrass the patient.
- Nurses do not identify patients by name or post or publish information that may lead to the identification of a patient. <u>Limiting access to postings through privacy settings is not sufficient to ensure privacy.</u>
- Nurses do not refer to patients in a disparaging manner, even if the patient is not identified. □ Nurses do not take photos or videos of patients on personal devices, including cell phones. Follow employer policies for taking photographs or video of patients for treatment or other legitimate purposed using employer-provided devices.
- Nurses maintain professional boundaries in the use of electronic media. Like in-person relationships, the nurse has the obligation to establish, communicate and enforce professional boundaries with patients in the online environment. Use caution when having online social contact with patients or former patients. Online contact with patients or former patients blurs the distinction between a professional

and personal relationship. The fact that a patient may initiate contact with the nurse does not permit the nurse to engage in a personal relationship with the patient.

- Nurses consult employer policies or supervisor within the organization for guidance regarding work related postings.
- *Nurses promptly report any identified breach of confidentiality or privacy.*
- Nurses must be aware of and comply with employer policies regarding use of employer owned computers, cameras and other electronic devices and use of personal devices in the work place.
- Nurses do not make disparaging remarks about employers or co-workers. Do not make threatening, harassing, profane, obscene, sexually explicit, racially derogatory, homophobic or other offensive comments.
- Nurses do not post content or otherwise speak on behalf of the employer unless authorized to do so and follow all applicable policies of the employer (NCSBN, 2012).
- Nurses update your privacy settings on a regular basis.

 The use of social media can be of tremendous benefit to nurses and patients alike. However, nurses must be aware of the potential consequences of disclosing patient-related information via social media. Nurses must always maintain professional standards, boundaries, and compliance with state and federal laws as stated in Board Rule 217.11(A). All nurses have an obligation to protect their patient's privacy and confidentiality (as required by Board Rule 217.11(E)) which extends to all environments, including the social media environment.

Consequences: The consequences of any breech in maintaining confidential and sensitive information about faculty, staff, students, employees, or institution will result in progressive disciplinary action up to and including expulsion from the School of Nursing.

Academic and Scholastic Dishonesty:

Scholastic dishonesty includes cheating on a test/assignment, plagiarism, collusion, use of AI to complete assignments, and falsifying records. Additional violations may be classified as scholastic dishonesty. Scholastic dishonesty will not be tolerated in the School of Nursing. Violation of scholastic dishonesty will result in the dismissal from the program. Policies and procedures are also in place at UTPB to address scholastic dishonesty violations. Please refer to the Falcon Guide for UTPB.

- Students may not collaborate with anyone else on assignments, quizzes, examinations, or any other academic work except as directed by the assignment/instructor's directions.
- Students may not resubmit any assignment or part of a previous assignment written, audio, or video recorded for which they previously received a grade. This applies to courses from which a student withdrew and/or in which a failing course grade was achieved.
- Students may not submit the same assignment (written or recorded) or portion of an assignment to more than one course unless specifically allowed or directed by the instructor's directions. This applies to both graded and non-graded assignments.
- Students may not resubmit any work which has previously been submitted for course credit at any
 educational institution unless prior written approval is received. Written approval for resubmitted
 work must be received from both the current course instructor and the instructor of the course in
 which the work was previously submitted.

- Students may not copy or share any course materials or documents, past or present assignments, nor quiz/examination questions on any social platform or publicly available website.
- Students may not seek, acquire, receive, or provide unauthorized information or assistance regarding an exam, quiz, or assignment (such as purchasing, using, or distributing any unauthorized course materials in order to gain academic advantage).
- Students are expected to accurately and completely document and record clinical practice hours completed and patient/client care activities. Falsifying any documents related to clinical hours or patient/client care activities (including documenting as fact, information not obtained through one's own direct assessment and examination of a patient or falsely recording clinical practice hours) constitutes dishonesty.
- Students are expected to accurately collect and submit data collected for completion of course and program requirements. Falsification of data or data collection methods constitutes academic dishonesty.

Cheating on a test will not be tolerated:

Therefore, the following list of activities during testing has been compiled to inform students what occurrences witnessed by the instructor will indicate cheating is taking place. If any of the below listed items are observed, the instructor will ask the student to close out their test and they will be removed from the classroom, a written report describing the occurrence will be sent to the Dean of Student Services, and the student will be removed from the nursing program. (See Test Policy Students)

- 1. Using a computer other than the one supplied by the School of Nursing.
- 2. Student observed talking to another student.
- 3. Student caught looking at another student's test.
- 4. Passing notes during a test.
- 5. Positioning scratch paper so it may be easily seen by others.
- 6. Student in possession of a phone or ear buds during testing.
- 7. Having scratch paper, other than what is supplied by the instructor.
- 8. Having open tabs on your computer at the time of testing.
- 9. Any tutorials opened during a test.
- 10. Refusing to let an instructor view the browser history.
- 11. Failing to start the test at the same time as the rest of the class.
- 12. Using a screenshot to have later access to test questions.
- 13. Using a "fall guy" to prep other students who were not at the exam on testing day.
- 14. Any other activity that is noted as suspicious during the exam. (rhythmic coughing, tapping on desk, tapping of feet, etc.)
- 15. Testing in online courses: Not completing an environmental check will be considered cheating.

Academic and Professional Standards:

All students enrolled at UTPB must subscribe to the standards and codes of the profession. Patients and society as a whole expect Undergraduate Nursing students, as professionals, to adhere to the:

- Texas Board of Nursing Unprofessional Conduct Rules
- American Nurses Association (ANA) Code of Ethics for Nurses
- American Nurses Association Scope and Standards of Practice
- American Nurses Association Guide to Nursing Social Policy Statement

Student Progression Policy:

- A grade of C (75) or better is required for each nursing course.
- Students must make a grade of 75 or better on the final exam regardless of the overall course grade and an average of 75 on all unit exams.
- A student must complete all coursework in the semester they are currently enrolled to continue to progress in the nursing program. If the student is unsuccessful in passing a course, the course must be successfully completed before continuing to the next semester's coursework.
- To successfully complete each course, all assignments must be completed and submitted.
- Late assignments will have a 10 point deduction every day they are late. If the assignment is turned in after the third day the assignment will be graded but a zero will be placed in the gradebook. If the student chooses not to turn in the assignment after three days (3) that will count as a missing assignment and the student will fail the course.
- Students are permitted to drop a course one time. All drops including academic and non-academic drops are also considered an attempt and will fall under the rule of a failed course. Students are required to meet with their Academic Advisor and the course lead prior to dropping. Compassionate withdrawals and withdrawal exceptions will be reviewed on an individual basis by the Progressions Committee.
- Students who fail a didactic course with an associated clinical course will fail both the didactic and clinical courses, both courses will need to be repeated, and vice-versa.
- Students may only repeat one nursing (NURS) course. If a student fails two nursing (NURS) courses or one nursing (NURS) course more than once during their admission into the nursing program, the student will be removed from the program. This includes both pre-admit nursing courses (NURS 3362 Theoretical and Evidenced Based concepts and NURS 3368 Pathophysiology).
- Students who need to repeat nursing courses must meet with the instructor and are encouraged to do so as soon as they are aware of the need to repeat a course. The student's need to repeat will be discussed at the Student Progression Committee where readmission will be determined. Students will be readmitted to courses and or program on a space-available basis as determined by the Progression Committee and as recommended to the Program Director.
- Students who fail a course in their fourth semester will receive an Incomplete in NURS 4120 Capstone course and be required to retake the course when repeating the failed course.
- A student who is removed from the program will be not allowed to reapply until they have set out for one year, once the student has met all current admission criteria they may reapply and the Admissions Committee will review the student along with other applicants before a decision is made to readmit.

All pre-admit and post-admit NURS courses fall under the rule of two (2) failed courses will be grounds for removal from the program.

Pinning Ceremony:

Students who have successfully completed all UTPB and School of Nursing requirements for graduation will be permitted to participate in the pinning ceremony. Pinning is scheduled the day before semester graduating ceremony (except summer graduation).

Student Evaluation of Teaching:

Every student is encouraged to complete an end-of-course evaluation/survey provided by UTPB. During the last few weeks of class, you will receive an announcement through email notifying you that the Course/Instructor Survey is available. You may follow the link in the email to complete the survey using the same credentials to access your courses here. When entering the emailed Survey link you will see a list

of surveys for you to complete. Another way to find End-of-Course Evaluations is through you my.utpb.edu account > My Surveys & Evaluations are on the first page after you login.

The survey is anonymous and your responses are confidential. Your feedback is critical to us and to your instructor as we strive to improve our offerings, and our support of you, the students.

The instructor and student will conduct a mid-term evaluation of the student's progress and develop, if needed, a plan to promote the student's success.

Committees:

Students may be given the opportunity to serve on standing committees within the School of Nursing.

Course Incomplete/Withdrawal/Grade Appeal

All students are required to complete the course within the semester they are enrolled. Incomplete grades for the course are rarely given, and will only be granted if the student provides a valid, documented excuse for not being able to complete the course on time, and has contacted the instructor **prior** to the scheduled last class to request an extension. The student signs a contract that includes the incomplete course activities and the new due dates.

To find information and dates regarding drops and withdrawals consult the University Calendar.

Academic Grievances:

If a student believes his or her grade was not appropriately assessed, the following steps should be followed:

- Make an appointment with the instructor involved to discuss the problem. Ask him or her for constructive feedback. Use this as an opportunity to grow and improve academically and personally.
- If this effort to resolve the matter is unsuccessful, the student will make an appointment with the Director and inform him or her exactly the perception of the problem. Ask for advice and constructive feedback to resolve the situation. A Grievance Committee may need to be formed to determine an effective resolution to the problem.
- If a resolution still has not been found, the student will make an appointment with the Associate Dean of Academic Affairs for the College of Health Sciences and Human Performance, then prepare a written statement of the grievance, and submit it to the Associate Dean of Academic Affairs prior to the appointment. Clearly state the problem and why you are dissatisfied. Give clear examples or evidence to support your position. The Associate Dean of Academic Affairs will review your grievance statement and will make a decision in consultation with you, your course instructor, and the Academic Chair.
- If a resolution still has not been found the Associate Dean of Academic Affairs presents the matter to the Dean of the College of Health Sciences and Human Performances. The Dean of the College of Health Sciences and Human Performance will review the grievance statement and will decide. Results will also be sent to the student, the instructor, Academic Chair, and the Associate Dean of Academic Affairs for the College of Health Sciences and Human Performance. If the resolution is still unsatisfactory to the student, the matter is then referred to the UT Permian Basin grievance personnel.

NCLEX-RN SUCCESS PLAN

The School of Nursing (SON) at the University of Texas of the Permian Basin is dedicated and designed to assist students achieve success in the nursing program, the nursing profession, and on the NCLEX-RN examination. Once admitted to the BSN program, all students are progressively evaluated and supported on academic success and professional development in the classroom, clinical setting, and the community. Successful completion of the entire NCLEX-RN Success Plan is required for graduation.

The NCLEX-RN Success Plan components are as follows:

- 1. Content Mastery Computerized Testing
- 2. Passing a grade of 75% in all didactic courses, an average of 75% on all unit exams, and passing of the final exam with a 75% or higher.
- 3. Submission of all assignments.
- 4. Satisfactory in all clinical courses
- 5. Professional behavior of caring and respect in classroom, clinical settings, university, and community.

Content Mastery Computerized Testing (ATI proctored Exams):

- 1. Throughout the nursing program, all students are required to complete content mastery computerized tests in selected courses.
- 2. The computerized content mastery tests (ATI proctored exams) in specific selected courses are a course requirement and must be completed successfully.
- 3. Content mastery proctored computerized test (ATI proctored exams) will comprise no more than 10% of the grade in specific required courses (see Table 1).
- 4. ATI proctored exams will only be offered twice in one semester per designated course.
- 5. The required computerized content mastery tests (ATI proctored exams) are proctored and must not be shared among students.
- 6. Each student is required to take ATI Content Mastery Test in the semesters listed below in Table 2. Students who achieve a Level 2 or Level 3 on the first attempt are not required to repeat the second test but may retake the test if they desire. Students who make a Level 1 or Below Level 1 are required to take a repeat Content Mastery Exam. All students will be required to complete a hand written remediation and submit it to the instructor of the course.
- 7. Students who achieve less than a level II on proctored exam, must meet with the course instructor and the COACH to receive an action plan.
- 8. A focused review must be completed before a second attempt is allowed.
- 9. In preparation for the proctored required computerized test the student must take two content practice tests in specific required courses and make at least 90% on each practice test.
- 10. The student may repeat the practice tests as many times as needed to achieve 90%. The repeat practice tests must be taken no less than 24 hours between the repeat test and the initial practice test; then 24 hours between each retest.
- 11. At the end of the first practice test the student must procure a printout of the remediation plan and topics that need improvement before repeating the same practice test.
- 12. The student should log in and complete a minimum of one-hour focused review on missed topics on the ATI website and complete a written focused review including three critical points to remember. Achievement of a 90% or higher individual score is required prior to taking the proctored test.
- 13. Students are required to show documentation of focused review by submitting a printed copy of the individual student transcript to the faculty prior to retesting.
- 14. Focused review consists of printing out the specific proctored "report" and using either the available ATI templates or a plain piece of paper to handwrite all the missed items under "Topics to Review" and label each missed item with the topic descriptors and rationales. This handwritten remediation will be stapled with the student's proctored "report". No cut and paste documents will be accepted.
- 15. ATI testing and learning resources are embedded throughout the nursing program. Please see individual course syllabus for details outlining grading policy. The grading system for proctored

exam scoring is outlined below. Students must take the second proctored exams if a Level 2 or Level 3 was not achieved on the first attempt.

16. NCLEX RN Predictor Test

 NURS 4120 Nursing Capstone provides a comprehensive in-class and online review of all the major content subjects of the nursing courses. The course last fourteen weeks and for eight weeks

students will take a series of practice and proctored exams with remediation, and an online coach will guide and assist in preparing students to pass the NCLEX-RN. The next six weeks is Virtual-ATI an individualized review with the same on-line coach to remediate and test on weak areas of content identified in the first eight weeks, week seven is a three day live review over identified weakness in content throughout the course and a review of test taking strategies.

- The course also provides students with guidelines to prepare for their first professional job, review scenarios for the Nurse Practice Act, instructions for applying to take the NCLEX-RN, and the ethical and legal implications of their nursing practice.
- In NURS 4120 Nursing Capstone, the student will receive the standardized Comprehensive Predictor Test and attend two 3-day Live Reviews.
- A three-day in-person face to face Live Review is given after the first Predictor Test attempt for the ATI Review.
- All students will complete 100% of the virtual ATI.
- After developing a personalized success plan, the student will take a second proctored predictor exam. Student must pass the proctored predictor exams with a score of 72% or higher to achieve a 92% or higher on the Predicted Probability of Passing the NCLEX-RN
- Once the ATI coursework and Live Review are complete the students will engage in a 3-day live review conducted by Hurst.
- 17. To practice nursing, a licensee must possess a multitude of knowledge, skills and abilities to provide safe and effective patient care (National Council of State Boards of Nursing, Inc., 1992). It is the University of Texas of the Permian Basin's School of Nursing responsibility to assure that this requirement is met before a graduate is certified.

Passing Grade of 75% in All Didactic Courses:

- 1. The simple average of all coursework must equal 75% along with an average unit exam grade of 75% or above and a final exam grade of 75% or above.
- 2. If a student makes less than 75% in any nursing course or less than a 75% average on unit exams or less than 75% on the final exam, the student will not progress in the nursing program.
- 3. If a student gets less than 75% on any exam in the course, the student must schedule an appointment with the instructor.
 - The instructor and the student will complete an exam review for discussion on topics missed, potential changes in studying, and test taking strategies.
 - The instructor and the student may complete the Loma Linda Exam Analysis Procedure, plan a remediation, and create a study plan together.
 - The instructor will keep the Loma Linda Exam Analysis Procedure, and study plan on file and give a copy to the student.
 - The student will complete the recommended study/remediation activities.
 - The course instructor will place a *Hold* on the student's record and will not allow the student to take the next major exam until the study/remediation plan goals have been successfully met.
 - The student must attend and actively engage in all mandatory Study Halls conducted by faculty.
 - The student must sign in and show proof of attendance and participation to the course faculty.
 - The course faculty will remove the *Hold* on the student's record and allow the student to take the next major exam.
 - The student must complete all study/remediation activities prior to the next scheduled exam.

4. A student must complete all coursework in the semester they are currently enrolled to continue to progress in the nursing program. If the student is unsuccessful in passing a course, the course must be successfully completed before continuing to the next semester coursework.

Satisfactory in All Clinical Courses:

- 1. A grade of Satisfactory in all clinical courses must be achieved to progress in the nursing program.
- 2. When clinical and didactic courses are co-requisites: both the didactic course and the clinical course must be passed to progress. A failure in one class results in a failure in the co-requisite class.
- 3. A student must achieve a Satisfactory (S) in a clinical course to receive a passing grade of 75% (C) or better in the associated didactic course.
- 4. A student must achieve 75% (C) or higher, 75% or higher average on unit exams, and pass the final exam with a 75% or higher in a nursing didactic course to receive a passing grade of Satisfactory (S) in the clinical component.
- 5. Therefore, if a student makes less than 75% (C), or does not have an average of 75% on all unit exams, or does not pass the final exam with a 75% or higher in the didactic course they will also receive Unsatisfactory (U) in the clinical course or vice versa, They must repeat both courses and receive a passing grade in each course to progress.
- 6. A student cannot enter the clinical at the hospitals or other designated clinical sites unless the student is concurrently enrolled in both the clinical and didactic course simultaneously.

Clinical Attendance Policy:

- 1. As students' progress though the UT Permian Basin School of Nursing program, the clinical and simulation experiences assist them to apply knowledge and skills they have learned in each nursing course. A minimum number of clinical hours are required to achieve each course requirement as well as attain the standard hours set forth by the Texas Board of Nursing.
- 2. Students are expected to attend and participate in all scheduled simulation and clinical experiences. The UT Permian Basin School of Nursing has zero tolerance for clinical or simulation absences.
- 3. Students can have no more than one clinical absence a semester.
- 4. Attendance for all classes is mandatory. The student must be present and on time for all classroom and clinical classes. There are no excused absences. Three tardies will result in one absence.
- 5. A mandatory make-up day will be set by faculty based on availability.
- 6. In the event a student misses more than one day of clinical, including simulation lab hours, or a scheduled make-up day, this may result in course failure.
- 7. The School of Nursing recognizes that there may be extenuating circumstances or an illness which might prevent a student from attending clinical or simulation experiences. Students will submit documentation for each clinical absence which will be placed in their permanent file, and one make-up day will be scheduled.
- 8. If the student misses any scheduled clinical make-up without proper notification to faculty and or clinical agency, the missed day will serve as an absence and the student may fail the course. As students' progress though the UT Permian Basin School of Nursing program, the clinical and simulation experiences assist them to apply knowledge and skills they have learned in each nursing course.

Professional Behavior of Caring and Respect in Classroom, Clinical Settings, University, and Community:

Faculty and students are expected to conduct themselves professionally; in demeanor, use of language, and appearance in the presence of faculty, staff, other students, patients, and visitors in the classroom, laboratory, and health care settings and in the community.

Classroom Environment:

Faculty and students are expected to uphold a classroom atmosphere conducive to learning. The faculty is committed to providing the curriculum in a manner that will prepare graduates to be successful in the health care workplace. It is expected that students will be ready to work and listen at the beginning of

class and after breaks. Professional behavior means that students do not have to be called to order more than once.

Classroom Conduct:

Professional demeanor and courtesy to peers, faculty, and guests and/or guest lecturers in the classroom setting are essential to the teaching-learning experience. Classroom conduct is expected to demonstrate mutual respect between faculty, students and peers. Elected course representatives will participate in the management of peer classroom conduct.

Communication:

Communication is expected to be professional in all encounters. Foul or abusive language in the classroom, clinical setting, or university will not be tolerated. Conflicts are to be resolved in a manner that respects the dignity of every person involved.

Consequences of Unprofessional Behavior:

Student will be dismissed from the Nursing Program for unprofessional behavior or conduct that is detrimental to the university.
